Purpose of the award:

This award will recognize one Faculty DEI project, with an award of \$700. This award is meant to recognize faculty efforts to increase diversity, equity, and inclusion within CASE specifically. This award may cover a specific project or classroom efforts to support diversity, equity, and inclusion, including undergraduate and graduate education.

Number of awards and award amount:

There will be one \$700 award per year.

Who is eligible to be nominated?

All CASE affiliated full-time ranked faculty and NTT faculty are eligible.

Current members of the Faculty Leadership Council are not eligible.

Timeline for 2024 awards:

March 15: Complete nomination package due to CASE Dean's office. Submit to CASE@mst.edu

April 10: Faculty Leadership Council Awards Committee to submit recommendations to the

CASE Dean

April 15: Nominees informed of decision

Winners will be recognized at the CASE College-wide meeting at the end of the Spring Semester.

Nomination materials:

- 1. Nominee's CV, highlighting DEI activities for the past three years.
- 2. DEI statement (500 words max) from the nominee, focusing on why their work may be worthy of recognition, based on the award's criteria.
 - a. **Significance** How has the DEI initiative demonstrated inclusive leadership and commitment to the development, embedding and sustainability of diversity, equity and inclusion within the CASE community?
 - b. **Innovation** How has the DEI initiative uniquely addressed key issues of diversity and inclusiveness within the CASE community?
 - c. **Impact** What have been the measurable outcomes? How has this project/program/activity "moved the needle" in addressing issues of diversity and inclusiveness in the CASE community and/or throughout the university?
- 3. Maximum of 5 supporting documents which may include any of the following:
 - a. documentation related to their DEI project,
 - b. supporting letters from colleagues or students you have worked with who have observed your DEI work or have been impacted by or benefitted from your work,
 - c. supporting letter from department chair (if the chair is not the nominator).
- 4. Signatures are required from the nominee, nominator, and chair.
